Inside:


- ◆ Don't prop open doors. It may be a hassle, but the security is worth it.
- ◆ Lock your door and your windows, even if you leave for a few minutes. Don't leave an open invitation.
- ◆ Watch your keys. Don't lend them, and don't put your name and address on your key ring.
- ◆ Watch out for unwanted visitors - know who is on the other side of the door before opening it.
- ◆ Watch those isolated spots, such as parking lots and restrooms, especially late at night. Go with a friend or use the campus security guard.

Outside:

- ◆ Avoid walking or jogging alone, especially at night. Vary your route; stay in well-lighted and traveled areas.
- ◆ Have your key ready before you reach the door (home, car or at work).
- ◆ Drive on well-traveled streets and keep doors and windows locked.
- ◆ Never pick up a hitchhiker, no matter how nice they look.
- ◆ Keep your car in good working order with plenty of gas in the tank.

Campus Security Report

Crimes on Campus
January 1, 2019 - December 31, 2019



Locklin Technical College is required to provide students and employees an annual report of information regarding campus security policies and campus crime statistics.

Role/Function of Campus Security Personnel

Locklin Technical College presently provides duty personnel and a school resource officer to assist students in the event of a campus security problem. The school resource officer is a sworn deputy and has full authority to arrest individuals.

LTC procedures for reporting and responding to reports of emergencies and crimes:

- ◆ Students should report any emergency or crime to an instructor, counselor, school resource officer or administrator.
- ◆ These personnel will determine which resource to contact: Counseling, Medical, Law Enforcement (Sheriff's Department or State Trooper).
- ◆ Law enforcement and/or medical services will be available to respond to reports of emergencies and/or crimes reported on campus.
- ◆ Follow-up information on the reported crimes will be available to the students or employees involved upon request.

CAMPUS SECURITY ACT



POLICY AND PROCEDURES RELATING TO SEXUAL ASSAULT

Locklin Technical College will not tolerate sexual assault in any form, including acquaintance or date rape. Where there is probable cause to believe that Locklin Technical College regulations prohibiting sexual assault have been violated by a student, the staff will pursue disciplinary action which may include sanctions up to and including expulsion from the Center. A student accused of sexual assault can be prosecuted under the Florida Criminal Statutes. Even if criminal justice authorities choose not to prosecute, the Center may pursue disciplinary action.

Prevalence of Sexual

Every two and a half minutes, somewhere in America, someone is the victim of sexual assault. One in six American women have been a victim, and 10% of victims are male. Almost two-thirds of all sexual assaults were committed by someone who is known to the victim.

About 44% of rape victims are under age 18, and 80% are under age 30.

Definition

Florida Statutes define sexual battery as: Oral, anal, or vaginal penetration by or union with the sexual organ of another or the anal or vaginal penetration of another by any other object. *Section 794.011(h) Florida Statutes.*

Criminal Penalties

The commission of sexual battery is a felony in the state of Florida. Felonies are classified into categories with prescribed penalties, which can range from life imprisonment for a capital felony to five years imprisonment for a felony of the third degree. Whether a person is charged and/or convicted of a particular felony will depend upon certain acts or circumstances existing during the commission of the sexual assault, such as age of victim, the use or threat of a deadly weapon or use of actual force likely to cause personal injury.

Procedures for Reporting Sexual Assault

Students are strongly encouraged to report sexual assault. Caring assistance will be available to you. The counselors, teachers, and administration will treat you with respect, dignity, and sensitivity and will ensure that you are taken promptly for medical care and collection of evidence. Information regarding options and legal action is available.

If you are raped:

Report the rape to an instructor, counselor, school resource officer or administrator. Do not bathe, douche, change clothes or rinse your mouth. These actions may destroy evidence. Seek medical help. The police and hospital staff are trained to help you.

The Rape Crisis Center also provides free 24 hour confidential telephone counseling to rape victims and their families. Counselors are available for incident specific counseling. Male representatives are also available. Contact the Rape Crisis Center at 850.433.RAPE (7273)

Victim's Rights

To ensure fairness to victims of sexual misconduct, Locklin Technical College is committed to providing the following rights:

1. The right to have a person of choice accompany the victim throughout the discipline process.
2. The right to remain throughout the disciplinary hearing.
3. The right to make a victim impact statement and to suggest an appropriate penalty if the accused is found guilty.
4. The right to be informed of the outcome of the discipline process.

Ways to Avoid High-risk Situations

Never take your safety for granted. Always take basic safety precautions and be aware of the possibility for danger in any setting.

Be Alert

Show that you're in control (walk with confidence). Be aware of your surroundings (notice who is around, what is going on). Don't let alcohol or other drugs fog your judgment. Be assertive...do not let anyone violate your personal space.

Trust Your Instincts

Feel uncomfortable? Unsure of the area? Get out! Make a scene if necessary. Don't be embarrassed. Do what is best for you.
